





### Wednesday Morning, May 9, 2018

Challenges in Clinical Supervision CPCS WA This program addresses possible problem areas a supervisor might face, such as poor boundaries, appropriate documentation, perfectionism, defensiveness, and more. Through case studies, these issues will be examined and possible solutions reviewed.

Carolyn A. Ramp, LPC, NCC, ACS, CPCS, has a Masters in Counseling from Augusta State University and a Specialists Degree in Counseling from Georgia Southern. She has been an Adjunct Professor at Augusta State University in the graduate counseling program. She owns Resolution Counseling Professionals in Augusta.

### Dissociation: The Missing Link MH

WA Have you ever wondered why some of your clients are so difficult to work with? It could be that dissociation is the reason! Attendees will learn about dissociation, the fundamental concepts of internal family systems theory, and gain new techniques to utilize when working with dissociation.

Kelly J. Veal, PhD, LPC, CAADC, is the Clinical Coordinator for the Clinical Mental Health Counseling program at LaGrange College, and the owner of The Veal Group, LLC, a private practice specializing in EMDR therapy.

#### The Opioid Epidemic: What Do We Need to Know? A

WA

Public health officials have called the current opioid epidemic the worst drug crisis in American history, killing more than 63,000 people in 2017. Opioids are a prime contributor to our addiction and overdose crisis. In 2015, nearly two-thirds of drug overdoses were linked to opioids like Percocet, OxyContin, heroin and fentanyl. This session will provide an overview of the opioid epidemic, how the DSM 5 views Opioid Use Disorder and current treatment of opioid-related conditions, including treatments provided by general practitioners and specialists in substance-use disorders.

Pierluigi Mancini, PhD, of Colombian and Italian descent, is the founder and former CEO of CETPA, Georgia's only Latino behavioral health agency providing affordable, cultural and linguistically appropriate prevention, intervention and treatment services in English, Spanish and Portuguese. Currently, Dr. Mancini is the President of the Multicultural Development Institute, Inc., an organization dedicated to bridging the gap between cultures affecting access and delivery of health and behavioral health services through education and training. Dr. Mancini has been providing multicultural training and education services at the local, state and national level since 1999.

#### Attachment, Grief, and Trauma: A Cord of Three Strands T

Every relationship produces an inimitable attachment of two unique individuals. Death severs that attachment, producing a physiological and psychological response that mirrors trauma responses. When a limb is lost, amputees experience phantom sensations of the missing limb, as if the limb is still present; similarly, grieving individuals seek to reestablish the lost attachment, searching for their missing other but finding emptiness. The grief process is presented through the lens of attachment theory and current research on trauma treatment, and treatment implications are explored.

W. David Lane, PhD, LPC, LMFT, CPCS, was founding faculty member of the graduate counseling programs at Mercer University where he is Professor of Counseling. He is co-author of Trauma Narrative Treatment, a training program for individuals working with trauma victims that has been used nationally and internationally. He has presented at national and international conferences on trauma, grief and loss, marriage counseling, spirituality, and ethics. He lead four separate training workshops for pastors and teachers in Haiti following the 2010 earthquake, and in Newtown, CT, following the Sandy Hook shootings.

Donna E. Lane, PhD, is Adjunct Professor of Counseling at Mercer University, and a Christian counselor in private practice since 1993. She is co-author of Trauma Narrative Treatment.

#### Images of Affair Recovery MH

Infidelity can be a devastating trauma to an individual and a system. As with any trauma,

the story quickly becomes overwhelming and unmanageable. Stories, images, and narrative techniques can provide structure and form to the trauma and recovery path providing guidance and hope. This workshop will explore several images that can be used with clients to help shape and guide their recovery.

Michael Sytsma, PhD, LPC, CST, CPCS, is the director and Senior Therapist at Building Intimate Marriages, Inc., where over 75% of his case load is helping couples recover from affairs. With over thirty years of experience in the field, he is a professor, mentor, supervisor, and sought after marriage and sex counselor.

#### Getting a Handle on Assistance Animals MH

In March 2018 Delta airlines imposed stricter rules for passengers who bring service and emotional

support animals on flights. The carrier indicated an 86% increase in incidents such as biting, behaving aggressively, and urinating. They now require passengers to provide a letter from a qualified professional such as a LPC. What would you do if a client asks you to write a letter? This session will increase participants' knowledge and understanding of emotional support animals and their responsibility to conduct a proper assessment before writing a letter of any kind.

Michell L. Temple, EdD, CRC, NCC, CPCS, LPC, has worked in higher education disability services for nearly ten years. She has spent nine years serving as an authority in granting accommodations for emotional support animals within a university residence hall. Dr. Temple is well versed in the research, education, and legislative complexities of supporting clients' request for assistance animals.

Delia Regalado is currently completing her Masters in Clinical Mental Health Counseling and Gerontology at Georgia State University. Interests include older adults, disabilities, depression and anxiety.

### Wednesday Afternoon, May 9, 2018

Supervision: Working with Veterans CPCS

Clinical supervision with veterans and active duty soldiers working with veterans is much different

than traditional supervision. This workshop will discuss four possible scenarios of supervision involving supervisors and supervisees with varying levels of experience.

Neil Duchac, DrPH, PhD, has worked for the state of Ohio in the Departments of Mental Health, Corrections and Rehabilitation, and Developmental Disabilities. Currently, he serves as a faculty member within the Department of Human Services and Social Work at Kennesaw State University.

Leslie McClane, MA, LPC, NCC, is the Field Coordinator and Clinical Assistant Professor of Human Services at Kennesaw State University's Department of Social Work and Human Services. She holds MA degrees in Counselor Education and Research from Appalachian State University, NC, and Clinical Psychology from Loyola University, MD. She has taught Human Services for 20 years, placed and supervised students in internships, conducted individual/group therapy, provided mobile crisis response, conducted/supervised assessments of families in the foster care system in community mental health clinics, a private psychiatric hospital, and a private agency for 30+ years.

Jennifer Leigh Bledsoe is an upcoming second year Master of Social Work candidate at Kennesaw State University. She worked as a Graduate Research Assistant at KSU and was recently inducted into Phi Alpha for exceptional academic achievement. She graduated with a Bachelor of Social Work from the University of Georgia in 2010.

### Addiction, Childhood Trauma, and Recovery A/TR

The Adverse Childhood Experiences study demonstrates links between childhood trauma and adult addiction, behavioral health issues, and diseases that adults die from. SAMHSA has determined that being trauma-informed is the minimum standard for behavioral health care and issued guidelines for its implementation in TIP 57. The presenter has conceptualized this progression of trauma-care as a pyramid and will review the steps to increasing your skills in trauma care from trauma-informed to trauma expert. After a brief review of the research, we will review assessment and educational tools to help clients understand more clearly the impact of trauma in their lives.

Denice Colson, PhD, LPC, MAC, CPCS, CCS, is co-founder and director of Eagle's Landing Christian Counseling Centers in McDonough and Conyers. As the Executive Director since 2007, she has facilitated their growth to 22 providers with a core vision of breaking the generational cycle of trauma. ### Diagnosing Suicidality: The Risks in Assessing Risk DXT/MH

An important part of the diagnostic process includes determining the potential risk for suicide. This workshop reviews methods for assessing suicidality within the framework of an integrated model, drawing from the principles of probability, necessary legal provisions, and detailed process tracking. An earlier version of this workshop was presented in 2014 to the clinical staff at Grady Hospital in Atlanta.

#### The Ethics of Providing Services to Military Aaffiliated Clients Through a Multicultural Lens

### When Your Supervisee is Experiencing Vicarious Trauma CPCS

This workshop will assist the supervisor in providing effective supervision to a supervisee who is experiencing vicarious trauma by proving awareness (signs, symptoms, cause) to the issue, offering effective supervision (identify various forms of supervision including reflective supervision), and providing clinical tools and coping strategies to assist the supervisee in becoming aware of vicarious trauma, compassion fatigue, and burnout.

#### A Conceptual Model for Doing Mindfulness-based Cognitive Behavioral Therapy MH

Loving-kindness and Chakra meditations are mindfulness-based practices designed to enhance feelings of kindness and compassion for oneself and others. This presentation showcases case studies of individuals suffering from anxiety and depression healed through these techniques. Through first hand experiential activities of guided meditation from presenters, participants learn about the importance of integration of body, mind and spirituality. Audience also learns how to assist clients to uncover and release hidden anxiety in a supportive manner.

Suneetha B. Manyam PhD, LPC, NCC, CPCS, is an Associate Professor at Mercer. She is a counselor educator for past eleven years and serves clients with anxiety, PTSD, and marital issues. She believes in holistic well-being integrating meditation into her therapy. She presents at regional, national, and international conferences and publishes papers.

Shama Panjwani, LAPC, NCC, CCMHC, is an LAPC, a doctoral student, and a crisis assessment counselor working with adults suffering from a variety mood and substance abuse disorders using a holistic approach.

She also serves with a community non-profit in her hometown.



#### Trafficked: Healing After Sexual Abuse TR

Due to the intense shame felt after sexual abuse, recovery can be a lifelong journey. However, there

are many tools to aid in the healing process. Attendees will learn to help their client challenge the lies they believe about the abuse and about themselves. Through lecture, visualization activities, and group discussion, this workshop will provide information on topics such as: memory work, dissociation, triggers, client manipulation, and the issue of sex trafficking.

Tammy Kennedy, MS, received her degree from Georgia State University in Community Counseling. She worked as a case manager for the Department of Family and Children Services for fifteen years and has many years of experience working in group homes for teens. In addition to her autobiography, From Rubble to Royalty, she has authored books for children who have been abused. ### The Congruent Supervisor: A Discussion of Ethics CPCS/E

### Look Who's Coming to Treatment: The Diversity of Eating Disorders MH/D

### Ethical Supervision of Addiction-Focused Counselors CPCS/A

In Clinical Supervision of addiction-focused counselors, it is necessary to have a familiarity with the Code of Ethics and Supervision Competencies developed by NAADAC (the Association of Addiction Professionals). Cooccurring disorders (COD) are complex and require that addiction-focused counselors have additional skills, abilities, and knowledge to work with the combination of mental health and substance use disorders. In addition, unique supervision challenges can occur because these supervisees are often in recovery from or have a family history of addiction. As gatekeepers, it is imperative that Clinical Supervisors can apply and integrate ethical decision-making models in addictions.

Moneta Sinclair, EdD, LPC, CPCS, MAC, has been a Licensed Professional Counselor since 2006 and is employed by Positive Impact Health Centers in metro-Atlanta. She is the agency's Director of Addiction Services and manages four addiction-related programs. Dr. Sinclair is a Certified Professional Counselor Supervisor (CPCS) and a Master Addiction Counselor (MAC). She is the co-owner of CASE (Counseling, Addiction, Supervision, and Education) Collaborators and provides supervision for graduate mental health interns, certified addiction counselors, and licensed and license-eligible professional counselors.

### Assessing Personal Theology in Psychotherapy MH
